### 10) Board Discussion – OLD Business –

- a. <u>McDonald Field Fire/Damage</u> On December 29<sup>th</sup>, 2024, a fire was set at McDonald field. There is significant damage to the back stop, fence, score box, dugouts, snack bar front doors, electrical by score booth, electrical by score box, trash everywhere, etc.
- b. <u>McDonald Field Repairs</u> The damage is much worse than we originally thought. It's not just something we can patch up and paint over (some of it is). There are still repairs needed on the outfield fence, that was set of fire last year! What is being done??......
  - Story/damage posted on our Facebook page it has been spreading like wildfire, and getting a lot of attention from the community, hopefully it's enough for us to get some help!!

- 2) <u>"GoFundMe" page started & posted on our Facebook page</u> it has also spread like wildfire.
  - We've gotten quite a few donations already (funds and volunteer help)!!!
    - a) As of today (1-14-24), we've raised \$2,345 through the "GoFundMe" page)!!
- Sunrise Park & Rec will pay for repairs they will submit an insurance claim or pay out of their budget. However, it's up to us to get bids approved and complete the repairs.

  - <u>Auxiliary Managers (McDonald)</u> We should have 2 Auxiliary Managers at <u>EACH</u> snack bar, to help share the work. Michelle and Valerie will take care of McDonald snack bar if we cannot find more Aux Managers.
